Alameda County's Budgeting Process Kicks Off with Final Budget Approval by June 30



This month, the Alameda County Board of Supervisors began to meet in budget work sessions to prepare the County's Fiscal Year 2022-23 Proposed Budget. The County's budget will identify how billions of taxpayer dollars are distributed for the next Fiscal year, July 1, 2022 through June 30, 2023 for spending in four main areas – health care services, public assistance programs, public protection, and general government services.

Alameda County is committed to an open and transparent budget process to ensure inclusiveness, accountability and trust. In the ensuing weeks, the Board of Supervisors, County Administrator, County Agency and Department heads, labor representatives, and various community stakeholders will meet to discuss budget policy impacts and reconcile their needs with available resources. The most important guiding principles used in creating a balanced budget include:

- Conserving our limited resources while sustaining core services;
- Incorporating budget equity principles; and
- Advancing the objectives of the **Board's Vision 2026**.

A critical aspect of this process includes the County Administrator's analysis of the proposed budgets submitted by County Departments and Agencies, and determining any Fiscal Year 2022-23 funding gap. The funding gap is the difference between the cost of maintaining current services and available financing. Any funding gap will be targeted for budget balancing in a collaborative effort among all of the stakeholders identified above.

Another critical aspect of this process involves an analysis of how State and federal funding and policy decisions will impact Alameda County residents. This analysis will be conveyed through reports that will be included in the Proposed and Final Budget documents.

In May and June, County departments will make any necessary adjustments to their initial proposals for final consideration by the Board of Supervisors. The Proposed Budget is slated to be presented to the Board in early June.

The Board will subsequently hold hearings for the public to offer comments to the Proposed Budget. This will be an important opportunity for Alameda County residents, businesses, and organizations to share their thoughts and feedback. The County anticipates receiving input and insights on how the Proposed Budget will impact significant issues such as criminal justice reform, the ongoing homelessness crisis, and the future of employment and safety net programs.

After public hearings, the Board will vote to adopt the Final Budget no later than June 30, 2022.

Cash Grants for Non-Profit and Business Organizations Impacted by COVID-19

Apply for up to \$100,000 in Relief!



Local non-profit and business organizations that have experienced negative economic, health, and safety impacts of the COVID-19 pandemic and are located in or serve residents of Alameda County are invited to apply for the American Rescue Plan Act **(ARPA) Community Needs Cash Aid Grant**. This program was launched by the Alameda County Board of Supervisors earlier this month.

Eligible organizations may receive cash aid grants up to the maximum amount of \$100,000 per Supervisorial District based on demonstrated and qualifying impacts. The total cash aid grants cannot exceed the amount of your organization's loss.

Through the application process, applicants must demonstrate and attest to the harm and economic loss sustained by the organization due to negative impacts of the COVID-19 pandemic. Priority will be given to organizations operated by or serving populations and communities that were disproportionately impacted by the COVID-19 pandemic.

Each Supervisorial District (five in total) has been allocated \$3.1 million to disburse grants. Grants are subject to availability of funds, eligibility of applicants, and any other relevant factors according to each Supervisorial District.

It wasn't until after she retired from her teaching job in 2020 that she finally decided to apply for our program.

"It looked like fun!" said Linda when asked why she decided to apply. "It was a great way for me to continue helping the community after I retired. I also like that I get to meet a wide variety of people and couples whose happiness are very contagious."



Teri (pictured left) has been volunteering as a Deputy Marriage Commissioner since the Summer of 2017. After retiring, Teri was looking for a fun way to remain active and a friend recommended that she apply for our Volunteer Deputy Marriage Commissioner program.

Teri has married over 2,100 couples throughout her five years at the Clerk-Recorder's Office. When asked what she enjoys most about volunteering in the program, Teri responded, "I love talking to all of the different people that I get to meet and learning about their decision to get married, especially after being together for years and years." Teri recounted a couple whom she married after 42 years of being together. "Their stories are always so interesting!"

Apply for Round Two of the Arts Relief Grant Program



Application Deadline: Friday, May 13, 5pm

Alameda County arts and cultural nonprofit organizations are encouraged to apply to this new opportunity! For more information, please review the **<u>Guidelines</u>** and apply through the **<u>Online Application</u>**.

Under the leadership of Melissa Wilk and the Alameda County Board of Supervisors, the Alameda County Arts Commission has helped to establish an **Arts Relief Grant Program** to provide funding assistance to nonprofit arts and cultural organizations negatively impacted by the COVID-19 pandemic.

Through this American Rescue Plan Act-funded grant program, it is anticipated that up to \$1 million will be provided to Alameda County arts and cultural nonprofit organizations that have experienced a negative economic impact as a result of COVID-19 during the period of March 1, 2020 to the present. Funding will be provided to arts and cultural organizations located throughout Alameda County with additional support provided to organizations located within the County's unincorporated areas.

Arts and cultural organizations who have received a grant through Round One of the Alameda County Arts Relief Grant Program in 2020 and/or through the Alameda County ARTSFUND Grant Program are still eligible to apply for the program, provided that all other eligibility requirements are met as outlined in the guidelines.



Presenting our Resources to the Community

The Auditor-Controller/Clerk-Recorder Agency offers many public resources, and we have been reaching out to various communities throughout Alameda County to let them know how we serve and support them. Hosted by Alameda County's Board of Supervisor Dave Brown, Melissa presented a virtual presentation to inform the unincorporated communities of San Lorenzo and Hayward Acres of our services and updates on April 20, 2022.

Our Agency was proud to be the first to offer full-time employment to a Raising Leaders graduate.
