June is also the month that the **Board of Supervisors** approved Alameda County's budget for Fiscal Year 2023-2024. # Board of Supervisors Approve a Balanced \$4.1 Billion Budget

On June 29th, after extensive discussion and stakeholder input, the **Board of Supervisors** approved Alameda County's budget for Fiscal Year 2023-2024. The budget is a balanced \$4.1 billion spending plan for County programs and services that closes a \$54 million funding gap and illustrates how the County leadership works effectively to best serve the community.



In the last three and a half years, the County has had to contend with the health, economic, and social impacts of the public health emergency due to COVID-19. The County was able to continue to administer vital County programs without cuts to service levels or staffing during this period as a result of Alameda County's history of longstanding prudent fiscal and budgeting policies. Alameda County's strategic vision will continue to guide the County through

challenges that might arise as we strive to achieve our goals of a Healthy Environment, a Prosperous and Vibrant Economy, Safe & Livable Communities, and a Thriving & Resilient Population.

The Alameda County budget website is part of the County's larger goal to provide information about our services in a user-friendly and informative format. It is designed to give community members a better understanding of how tax dollars are invested with highlights on funding for mandated and essential services. The County's annual budget is the window to the investments that the Board of Supervisors makes in the community on your behalf. You are invited to read the County Administrator's budget message that highlights the financial and policy issues contained in the FY 2023-24 Final Budget that was adopted by the Board of Supervisors on June 29. In addition, you'll find other budget-related information.

### **The Property Tax Process**



Every year I have the pleasure of partnering with the **County Assessor**, Phong La, on the annual property tax process. At the end of June our Agency receives the assessed values for all of the taxable property in Alameda County, as determined by the Assessor. During the months of July and August, our team calculates and applies the appropriate tax rates to the assessed values and extends the tax rolls. In other words, the Auditor-Controller determines the amount of taxes that are due. The tax rate that is applied to the assessed value is based on the location of the property and includes the amount necessary to

pay voter-approved debt in addition to the Countywide 1% tax. Most voter approved debt is in the form of General Obligation Bonds that have been approved as ballot measures during past elections. The Auditor-Controller also has the responsibility of adding any special assessments and/or fixed charges that are levied by other taxing districts in the County. After the Auditor-Controller completes their calculations, the **County Treasurer-Tax Collector** prepares and mails the property tax bills, and collects the taxes. As the last step in the process, the Auditor-Controller team apportions the tax collections to the County, cities, schools, and over 80 special districts.

# **Interns Gain Valuable Experience**

We are excited to shine a spotlight on two of our Interns, who are contributing to our Agency's success on a daily basis.

Our General Accounting Division is pleased to work with intern

Criselle Ong. Criselle began her internship in February and has been a valuable asset to our team. Criselle recently completed her Bachelor of Science in Business Administration Accounting from California State University, East Bay in June of 2023. She is a first-generation college graduate in her family and chose to work for the County because she has always had an interest in governmental accounting. Criselle is currently assisting the General Accounting Division with various tasks such as reviewing, recording and posting different transactions in the general ledger, including incoming State apportionments and other daily deposits. She is also gaining experience on the real-life application of accounting practices and principles in the County's financial system. Furthermore, she reviews and responds to inquiries from the public regarding claiming procedures for



County payments that remain uncashed for more than six (6) months. Criselle is a great and valuable addition to our Agency!



The Disbursements Division happily welcomed Isaih Hood in March 2022 to their team. Isaih is currently enrolled as a full-time student at San Francisco State University studying Communications and Business and will graduate in Spring 2024. Originally from Sacramento, Isaih moved to Oakland at age four and has been a Bay Area resident ever since. In addition to going to school, Isaih also works full-time with our Agency, reviewing claims and processing payments to County suppliers. During his internship, Isaih has also worked in the Small Local Emerging Business (SLEB) Certification Unit of which he shared, "being a part of the SLEB certification process allowed me to review financial records and ensure compliance with standards, which was both challenging and rewarding. My time in the Claims Unit has taught me valuable skills in analyzing data,

verifying transactions, and efficiently resolving issues. The supportive and welcoming environment made this internship a memorable and valuable learning journey, and I am grateful for the opportunity to contribute to the organization's mission." When he's not busy working and studying, Isiah, who formerly played college basketball at a Texas university, enjoys training and mentoring young men and women on the court and plays in a local league. Isiah has a positive, can-do attitude, and we are thrilled to have him on our Disbursements Division team!
