The November 5 election has brought changes in leadership at the local, county, state, and national levels. As the elected Auditor-Controller/Clerk-Recorder, I look forward to partnering

One of the key responsibilities of the Agency is managing Alameda County's payroll system, which ensures timely payments to over 10,500 employees. I want to thank our Payroll Unit for their hard work in diligently implementing an upgraded timesheet system that includes an improved time

study component, allowing departments to effectively track grant-eligible hours. By tracking and reporting these hours, we can help maximize the County's receipt of all eligible funding and maintain general fund resources that support essential programs and services.

We're also pleased to share the completion of testing for a new data transfer system with the Alameda County Employees' Retirement Association (ACERA). This improvement ensures that critical employee pay information is transferred seamlessly to ACERA, supporting accurate and efficient pension calculations for our dedicated employees.

During the Fall there are so many wonderful events in our region! In September, my team and I were delighted to participate in the Healthy Living Festival, hosted by the United Seniors of Oakland and Alameda County—one of the largest senior events in our area. Also in September, we participated in the Fall Festival in Castro Valley. And, in October we were at the Science in the Park event in Hayward. In honor of Veterans Day, we celebrated our County Veterans at the Veterans Art Exhibition event in Hayward. We're always excited to connect with community members and share valuable information about our services. Engaging with you helps us better understand your needs and ensures that our offerings truly benefit the people we serve.

#### **Annual Property Tax Bills**

Most property owners should have received their property tax bills in October for the 2024-25 tax year.

The annual property tax bills are prepared and mailed by the Treasurer-Tax Collector and include information provided by our Agency. The Auditor-Controller's Tax Analysis Unit is responsible for applying the 1% general levy and applicable voter-approved debt service rates (such as from school bond measures) to all property that is assessed in Alameda County. The



Tax Analysis Unit also compiles the fixed charges and special assessments (such as city library services and sewer services) that you see on your tax bill from the various districts. If you have questions about your property tax rate or the apportionment of your property taxes, please give us a call at **(510) 272-6564** and we'll be happy to help you. We're available Monday through Friday 8:30am-5:00pm.

At times, the County may need to adjust your tax bill, and you may be entitled to a refund. This typically happens when the County Assessor or Assessment Appeals Board lowers the assessed value of your property after the associated tax bill is paid. If this happens, the Auditor-Controller's Tax Analysis Unit will be happy to assist you – our refund service is provided directly to property owners at no cost!

# **ID E-Verification System**

Since implementing our ID E-Verification System, ordering birth, death, and marriage certificates online has become simpler and quicker. We received fantastic feedback from our community, and we highly encourage customers to take advantage of this convenient service. In the past, customers had to submit a notarized authorization statement or present identification in-person to pick up their orders. Now, with our ID E-Verification System, customers can verify their identity



online, saving valuable time and effort. This new process makes obtaining unrestricted copies of vital records more efficient.

# **Apostille Pop-Up Shop**

On September 26, the Alameda County Auditor-Controller/Clerk-Recorder Agency, together with the California Secretary of State's Office, hosted another successful Apostille Pop-Up Shop at the Dublin Public Library. An Apostille is a certificate that authenticates the signature of a public official on a document for use in another country.

We had a remarkable turnout with nearly 600 attendees in just one day, many of whom had traveled from all over California! Even though the event did not begin until 9:00 am, people were already lined up as early as 6:00 am! "Partnering with Alameda County for the Apostille Pop-Up Shop event exemplifies our dedication to serving Californians, wherever they may be," said California



Secretary of State Shirley N. Weber, Ph.D. Attendees were happy and appreciative to receive Apostille services without having to mail their requests in or make a trip to Sacramento.

#### **Participation in Statewide Professional Conferences**



In October, our Agency leadership attended the 79th County Auditors Conference, themed "21st Century Fiscal Stewardship." This annual event is presented by the California State Association of County Auditors.

I attended this important conference along with Laura Lloyd, Chief Deputy Auditor, and Craig Boyer, Assistant Controller of our General Accounting Division. We were honored to receive the "Award for County Financial Transactions Reporting" from

This event provided an invaluable opportunity to connect with colleagues and explore innovative strategies to ensure our office consistently upholds the highest standards of fiscal management and compliance with both State and local laws.

The conference began with an inspiring presentation by Malia Cohen who set the tone for discussions on topics critical to our work throughout California. Each session highlighted emerging technologies and best practices designed to streamline operations and improve service delivery. We gained fresh insights on managing the complexities of claims processing and received key updates from the General Accounting Standards Board to ensure alignment with evolving standards. Networking with auditors from California's 58 counties was particularly valuable, allowing us to exchange solutions and address shared challenges. Our attendance at this conference strengthens our Agency's commitment to maintaining strict compliance and best practices as we continue delivering critical public services effectively and responsibly to our community.

The 114th Annual Conference of the County Recorders' Association of California took place in September. The conference theme was "Riding the Waves of Change: Adapt, Innovate, Succeed." The conference addressed the evolving challenges and opportunities Clerk-Recorder Offices face in an increasingly dynamic environment. Our



Agency was represented by LaVette Grant who is a Clerk-Recorder Collections Supervisor. Given the many state laws governing how Clerk-Recorder Offices across California protect and manage the issuance of vital records and legal documents, it is essential that our team remains current with industry standards through dedicated training and professional conferences.

LaVette is a supervisor in our Scanning and Indexing Unit, where she oversees the digitization of property documents, ensuring each one is clearly scanned, accurately indexed, and thoroughly verified. This meticulous work is critical to making these documents easily searchable in historical records, preserving accessibility and accuracy for the public and future generations. At the

conference, LaVette participated in a panel discussion hosted by UC Davis Graduate School of Management. The panel featured county assessor, elections, and recorder personnel who shared insights into building and leading great teams to provide essential services for county residents. Reflecting on her experience, LaVette said, "Attending the conference not only strengthened my understanding of the regulations governing our work, but also inspired me to step back and evaluate my role as a leader in a field that has a direct impact on my community."

It continues to be our pleasure and honor to perform both in-person and virtual marriage ceremonies for so many happy couples at the Alameda County Clerk-Recorder's Office! Each year we perform over 2,600 marriages and issue over 6,500 marriage licenses and certificates.

All marriage ceremonies are by appointment only, and we have an **online reservation system** – or you can make an appointment by calling 510-272-6362. You can also have a

friend, family member or loved one marry you once they legally become an officiant.

Reminder that the Alameda County Clerk-Recorder's Office has two locations, one in Oakland and one in Dublin. The Oakland Office is located at 1106 Madison Street in Oakland and the Tri-Valley Office is located at 7600 Dublin Boulevard in Dublin.
