SUBJECT: PROCUREMENT UPDATE

Attached is an updated progress report on County procurement. The data presented in the report is for the period July 1, 2008 through March 31, 2011. The MBE/SLEB contract dollars only including amounts up to \$500,000 for this reporting period are \$111.0M which represents 44.70% of the total contract dollars. The total MBE/SLEB contract dollars (including amounts over \$500,000) for this reporting period are \$219.5M which represents 31.30% of the total contract dollars.
