SUBJECT: PROCUREMENT UPDATE

Attached is an updated progress report on County Procurement. The data presented in the report is for the period July 1, 2009 through December 31, 2012. The information presented in this report is based on payments made to contractors as opposed to prior reports that were based on contracts awarded. As you can see on Page A from the summary chart of all payments up to \$500,000 dollars for the period July 1, 2009 through December 31, 2012:

- Total payments up to \$500,000 were 364.0M dollars
- 248.7M dollars were paid to local contractors which equals 68.32% of total dollars up to \$500,000
- 190.1M dollars were paid to MBE/SLEB contractors which equals 52.21% of total dollars up to \$500,000
- Payments to MBE/SLEB contractors by category were:

Construction:	\$28.5M which is 53.98% of Construction dollars
A & E:	\$4.0M which is 47.25% of A & E dollars
Professional Services:	\$59.9M which is 58.71% of Professional Services dollars
Goods & Services:	\$97.7M which is 48.66% of Goods & Services dollars

Also included in this report are all payments to contractors including amounts over \$500,000. This information is presented in the summary on Page B and Pages 21 through 41.

- Total payments were \$778.9M dollars
- 517.0M dollars were paid to local contractors which equals 66.38% of total dollars
- 276.3M dollars where paid to MBE/SLEB contractors which equals 35.47% of total dollars

• Payments to MBE/SLEB contractors by category were:

Construction:	\$61.2M which is 39.54% of Construction dollars
A & E:	\$5.7M which is 27.60% of A & E dollars
Professional Services:	\$89.7M which is 28.61% of Professional Services
Goods & Services:	\$119.7M which is 41.31% of Goods and Services dollars

Currently the County has 1,395 certified SLEB vendors and approximately 11,000 MBE vendors. We are continually working to increase the number of SLEB/MBE vendors.
