SUBJECT: PROCUREMENT UPDATE

Attached is an updated progress report on County Procurement. The data presented in the report is for the period July 1, 2009 through December 31, 2013. The information presented in this report is based on payments made to contractors. As you can see on Page A from the summary chart of all payments up to \$500,000 dollars for the period July 1, 2009 through December 31, 2013:

- Total payments up to \$500,000 were 474.8M dollars
- 323.5M dollars were paid to local contractors which equals 68.13% of total dollars up to \$500,000
- 247.3M dollars were paid to MBE/SLEB contractors which equals 52.10% of total dollars up to \$500,000
- Payments to MBE/SLEB contractors by category were:

Construction:	\$34.7M which is 54.33% of Construction dollars
A & E:	\$6.0M which is 45.89% of A & E dollars
Professional Services:	\$78.5M which is 59.32% of Professional Services dollars
Goods & Services:	\$128.1M which is 48.24% of Goods & Services dollars

Also included in this report are all payments to contractors including amounts over \$500,000. This information is presented in the summary on Page B.

- Total payments were 1.02 billion dollars
- 668.0M dollars were paid to local contractors which equals 65.47% of total dollars
- 360.6M dollars where paid to MBE/SLEB contractors which equals 35.35% of total dollars

As of January 13, 2014 the County had 1,364 certified SLEB vendors and approximately 9,300 MBE vendors. We are continually working to increase the number of SLEB/MBE vendors.
