SUBJECT: PROCUREMENT UPDATE

Attached is an updated progress report on County Procurement. The data presented in the report is for the period July 1, 2009 through March 31, 2015. The information presented in this report is based on payments made to contractors. As you can see on Page A from the summary chart of all payments up to \$500,000 dollars for the period July 1, 2009 through March 31, 2015:

- Total payments up to \$500,000 were \$605.9M
- \$407.0M was paid to local contractors which equals 67.17% of total dollars up to \$500,000
- \$316.0M was paid to MWBE/SLEB contractors which equals 52.14% of total dollars up to \$500,000
- Payments to MWBE/SLEB contractors by category were:

Construction:	\$39.2M which is 51.40% of Construction dollars
A & E:	\$7.3M which is 44.65% of A & E dollars
Professional Services:	\$106.8M which is 61.33% of Professional Services dollars
Goods & Services:	\$162.7M which is 47.96% of Goods & Services dollars

Also included in this report are all payments to contractors including amounts over \$500,000. This information is presented in the summary on Page B.

- Total payments were \$1.34 billion dollars
- \$869.6M was paid to local contractors which equals 65.04% of total dollars
- \$470.6M was paid to MWBE/SLEB contractors which equals 35.19% of total dollars

• Payments to MWBE/SLEB contractors by category were:

Construction:	\$92.9M which is 36.15% of Construction dollars
A & E:	\$10.2M which is 30.94% of A & E dollars
Professional Services:	\$156.4M which is 28.91% of Professional Services dollars
Goods & Services:	\$211.1M which is 41.74% of Goods & Services dollars
