Attached is an updated progress report on County Procurement. The information presented in this report is based on payments made to contractors. The summary chart of all payments up to \$500,000 for the period July 1, 2009 through December 31, 2021 is shown on Page A1 and includes:

- Total payments up to \$500,000 were \$1.7B
- \$1.0B was paid to local contractors which equals 61.44% of total dollars up to \$500,000
- \$817.2M was paid to MWBE/SLEB contractors which equals 49.40% of total dollars up to \$500,000
- Payments to MWBE/SLEB contractors by category were:

Construction:	\$81.7M which equals 38.64% of Construction dollars
Architecture & Engineering:	\$22.1M which equals 51.76% of Architecture & Engineering dollars
Professional Services:	\$313.7M which equals 60.86% of Professional Services dollars
Goods & Services:	\$399.6M which equals 45.18% of Goods & Services dollars

Also included in this report are all payments to contractors including amounts over \$500,000. This data is presented in the summary on Page A2 for the period July 1, 2009 through December 31, 2021 and includes:

- Total payments were \$3.7B
- \$2.1B was paid to local contractors which equals 55.60% of total dollars
- \$1.3B was paid to MWBE/SLEB contractors which equals 35.86% of total dollars
- Payments to MWBE/SLEB contractors by category were:

Construction:	\$215.7M which is 30.29% of Construction dollars
Architecture & Engineering:	\$27.0M which is 35.46% of Architecture & Engineering dollars
Professional Services:	\$418.9M which is 30.67% of Professional Services dollars
Goods & Services:	\$662.9M which is 43.05% of Goods & Services dollars
