Attached is an updated progress report on County Procurement. The information presented in this report is based on payments made to contractors. The summary chart of all payments up to \$500,000 for the period July 1, 2009 through June 30, 2022 is shown on Page A1 and includes:

- Total payments up to \$500,000 were \$1.7B
- \$1.1B was paid to local contractors which equals 60.88% of total dollars up to \$500,000
- \$862.2M was paid to MWBE/SLEB contractors which equals 49.34% of total dollars up to \$500,000
- Payments to MWBE/SLEB contractors by category were:

Construction:	\$85.1M which equals 38.61% of Construction dollars
Architecture & Engineering:	\$23.6M which equals 50.59% of Architecture & Engineering dollars
Professional Services:	\$333.0M which equals 60.65% of Professional Services dollars
Goods & Services:	\$420.5M which equals 45.14% of Goods & Services dollars

Also included in this report are all payments to contractors including amounts over \$500,000. This data is presented in the summary on Page A2 for the period July 1, 2009 through June 30, 2022 and includes:

- Total payments were \$3.9B
- \$2.1B was paid to local contractors which equals 54.84% of total dollars
- \$1.4B was paid to MWBE/SLEB contractors which equals 35.84% of total dollars
- Payments to MWBE/SLEB contractors by category were:

Construction:	\$223.2M which is 29.88% of Construction dollars
Architecture & Engineering:	\$28.4M which is 35.56% of Architecture & Engineering dollars
Professional Services:	\$447.7M which is 30.64% of Professional Services dollars
Goods & Services:	\$699.1M which is 43.31% of Goods & Services dollars
