Notice is hereby given by the Alameda County Community Development Agency, Planning Department as a lead agency pursuant to the California Environmental Quality Act (CEQA), that the above named Mitigated Negative Declaration (MND) is available for public review and comment. The Castro Valley Municipal Advisory Council (Council) and the Alameda County Planning Department will hold a public hearing to take comments on a Mitigated Negative Declaration for consideration of a proposed tract map and rezoning to a Planned Development (PD) District and General Plan Amendment, on five adjacent parcels located at 16286–16290 Foothill Boulevard and 2085 Miramar Avenue.

The project is to allow 56 townhomes and 6,000 sq. ft. of commercial space on 4.73 acres. The following planning approvals are requested by the applicant to permit the construction of this mixed-use development:

- 1. General Plan Amendment land use designation on sections of the site from "RLM" Residential Low Density Multi-Family (13-22 du/acre) to Neighborhood Commercial Mixed Use (22 du/acre)
- 2. Planned Unit Development to allow rezoning the project from "R-S-D-20" (Suburban Residential, 2,000 sq. ft. mbsa per du) and "CN" Neighborhood Business" to "PD" Planned Unit Development District for mixed-used development.
- 3. Tract Map Subdivision
- 4. Site Development Review

A Mitigated Negative Declaration, which is a written statement indicating that the proposed project will not have a <u>significant</u> effect upon the environment if appropriate mitigation measures are imposed, is proposed to be adopted pursuant to the California Environmental Quality Act and State and County CEQA Guidelines. Possible environmental impacts of this project include construction dust and drainage effects, subsurface archeological resources, seismic safety, stormwater runoff and flooding, and construction noise. The review period for the Initial Study and Draft Mitigated Negative Declaration is from March 28, 2016 to April 27, 2016. The Council will take public testimony and make a recommendation to the Planning Commission based on area concerns that will be considered prior to any action to approve or deny the project. No final action will be taken on the current application prior to adoption of the final MND by the Planning Commission.
