PLN2021-00202 / COMMUNITY HOUSING DEVELOPMENT CORPORATION, SB 35 MINISTERIAL

REVIEW, application to allow construction of a four-story, 40-foot tall (to top of parapet), 42 affordable housing studio units plus one, 2-bedroom manager's dwelling unit, a community room and associated office, and 32 on-site parking spaces, located on a property that also contains an existing church (church to remain), at 2889 Kelly Street, Fairview area of unincorporated Alameda County, and in the *Fairview Area Specific Plan*, "R-1" Single-Family Residence zoning district, and in the *Fairview Land Use Map*, land use designation of "Low Density Residential", with County Assessor's Parcel Number (APN): 416-0180-020-00. Because the State Statute mandates that the project review process is ministerial and that projects are judged purely on objective standards that do not involve the exercise of discretion, the California Environmental Quality Act does not apply to the Senate Bill 35 (SB 35) process: Title 14 of the California Code of Regulations, Section 15268(a): "Miller erial pieces examples to the results of CEQA".
