On June 28, the Board of Supervisors hosted a special reception for about 150 local residents who serve on a wide array of County Boards and Commissions. The event was a rare opportunity for Board members to express their appreciation to the mostly volunteer contingent for their oftenoverlooked efforts to provide service that is essential to County operations. There are more than 800 Boards and Commissions members who advise County Supervisors on a wide range

of issues, from consumer affairs to public art projects, public health, youth policy, mental health issues and many other important policy areas. The Alameda County Fair Commission, established in 1905, is the longest active commission in the County. It is followed by the Alameda County Planning Commission, established in 1929.

There is an ongoing need for Alameda County residents to apply for positions on County Boards and Commissions. Those interested in serving may find Alameda County's annual Leadership Academy program to be a great entry point for this kind of service.

The Academy meets each fall for six sessions, and begins this October. In the Academy, top County officials engage participants in interactive exercises to teach leadership skills and enhance public knowledge of the workings of local government.

Employee Honored for "Heroic" Act

Gibson Douglas, a Bridge Tender for the Public Works Agency, was honored by the Board of Supervisors on July 24 for saving the life of a man who was attempting to leap from the Fruitvale Avenue Railroad Bridge.

Douglas was working on the bridge that connects Oakland and Alameda at about 4 a.m. on May 31 when he encountered a man who was visibly distraught and expressing a desire to end his own life. Gibson called 911 for assistance, but when the man began climbing over the bridge railing Gibson realized he needed to act.

Douglas reached out and wrapped his arms around the man and prevented him from jumping off the bridge, which rises 65 feet above the Oakland Estuary. He then engaged the man in a conversation that urged him to consider his faith and the suffering his death would cause to his friends and family. This allowed enough time to pass for the Alameda Police to arrive at the scene and help to detain the man.

Landmark Medication Disposal Ordinance Approved

OAKLAND, July 24, 2012 — The Alameda County Board of Supervisors in July passed a new policy, the first in the country, requiring drug companies to pay for collecting and disposing of leftover drugs they manufacture. The unanimous decision positions the County as a national leader for its producer responsibility approach on addressing the problem of what residents should do with their unused and expired medications. Currently, there are 28 med collection sites throughout Alameda County, which dispose of discarded medications at a cost of \$40,000 per year. The collection sites are operated by 10 different organizations and labor is donated by many participating organizations such as East Bay Municipal Utility District, Union Sanitary District and the City of San Leandro. Of the annual \$186 million in profits generated by drug companies in Alameda County, officials say the projected cost of a comprehensive producerfunded program would be about 1 cent for every \$33 of pharmaceuticals sold in the County. The landmark ordinance mandates that pharmaceutical companies design, operate and fund a collection program. The effort has attracted wide support from a variety of cities and agencies throughout the Bay Area and across the country struggling with the same issue.

the Taipei Economic and Cultural Office in San Francisco. "Maybe the ideal and practice of social enterprise is likely to provide some exchange and cooperation opportunities between Alameda County and Taiwan," she said.
