Notes:

- 1. Unless otherwise specified on the face of this Permit, movements shall be limited to travel in either direction through those roadway segments described in this column and only during the <u>non-holiday</u> weekday hours indicated. Movements through any under- or overcrossings of State Routes located in this roadway segment require State permits, movements through contiguous City roadways require City permits, and movements onto contiguous roadways maintained by any of the adjacent counties (Contra Costa, San Joaquin, or Santa Clara) require permits from the affected County; the restrictions and limitations imposed by these other agencies may or may not be the same as those described in columns 3, 4, and 5.
- 2. Weekend movements on roadway segments listed as "suitable" are authorized only if so indicated on the face of this Permit.
- 3. After-dark movements on roadway segments listed as "suitable" are authorized only if so indicated on the face of this Permit.
- 4. Movements requiring a pilot car escort are <u>not</u> authorized for either weekend or after-dark travel.
- 5. Movements requiring escorts by multiple pilot cars and/or by a uniformed police officer are <u>not</u> authorized for travel under this Permit.
- 6. Movements on Arroyo Road are restricted to a vehicle/vehicle combination/load with a permit load rating of OOOOO.

- 7. Movements on Castro Valley Boulevard between the intersection with Strobridge Avenue and the intersection with Lake Chabot Road are restricted to a vehicle/vehicle combination/load with a permit load rating of GGGGG.
- 8. Access to the bridge must be authorized by separate transportation permits issued by the cities of Alameda and Oakland.
- 9. Movements on Meekland Av. between the intersection with East Lewelling Boulevard and the intersection with Paseo Grande are restricted to a vehicle/vehicle combination/load with a permit load rating of PGGGG.
- 10. Movements on the Park St. bridge are restricted to a vehicle/vehicle combination/load with a permit load rating of PPGOO.
