- Inta If TAB is interested I could put together a presentation for the next meeting.
- Motion carried to exempt county mandated work by TAB

### V. Follow Up Items: (that need to be reported back to the TAB)

#### -Violations

- Inta I am going to look into talking with County Council about changing letter and giving them 3 options. Dig up the tree and move it, buy a new tree and put it into the right of way, or to sign waiver that would give the County jurisdiction over the tree.
- Steve There are two accounts that are set up in the fiscal dept. in which to use for fines and application fees. When we collect monies for these we can use the money in that geographical area.
- Dan Are the accounts restricted? Only used for tree purpose, designated use.
- Steve We can use them for tree related projects, but I'm not sure if they're that restricted. They are Urban Forestry related funds.
- Don N. Is there auditing done on this?
- Lupe I'm sure we'll be required to keep records, but I'm not sure about the county auditors office.
- Don N. Do we have a dollar figure for each account?
- Steve- \$200 in fines account, I don't have a \$ amount for the applications account.
- Dan Would we need the county supervisors approval to access these funds?
- Inta We would need Don Labelle's approval.
- Don N. If someone is fined, do they pay the fine then the appeal?
- Inta I'm currently working on a flow chart of what the appeals process will be and will hopefully have one by next meeting.
- Kathie What's the county doing to push PG&E to give us our money for damaging trees in San Lorenzo? This happens year after year. Maybe Don Labelle can put

some pressure on the Board of Supervisors to go forward with this. Is it possible for Don to write a letter to PG&E informing them that their contractor permit will be revoked if some type of resolution has not been reached within a certain period of time? Several attempts have been made to recover money for the restoration of the trees.

- Don S. Suggests putting an article in the paper. Use the media to put pressure on PG&E.
- Inta Gordon Galvin is head of Public Relations at PG&E.
- Dan Suggests writing a letter to Gordon documenting events and costs for restoring trees.
- Inta I'll be rewriting guidelines created in response to PG&E and the tree-trimming problem.
- Dan Sounds like our only strength is to issue notification that they will not be issued a permit until they resolve the problem.
- Inta- If money is collected from PG&E, it's supposed to pay for the flyers we're putting out in San Lorenzo regarding planting, trimming of trees, permits, etc...
- Dan Requesting bullet notes of everything that is to be pursued before the next meeting (an action plan for each issue).
- Inta Lupe will talk to Don L. tomorrow in one on one meeting about:
  PG&E has not come through with commitment to pay \$25k to San Lorenzo Homes Association.
  - Kevin Dowling has made many attempts to resolve issue
  - Discuss different options available to see which direction we should go from an agency perspective.
- Inta Will ask about the Statute of Limitations when I talk with Ray.
- Inta We had one violation last month and a couple of permits out of compliance. We have language in our ordinance that allows us to complete the work and bill the property owners. I had issued 3 work requests where we will be purchasing and planting the tree and then billing the property owners.

## -Ordinance Adjustments

- Inta suggest removing "ordinance adjustments" as a follow up item and rather keeping a record of proposed changes. When we have a significant amount I'll bring them back to the TAB and revisit them to determine whether to go to the Board of Supervisors to change the ordinance.
- Inta Last meeting Dan had a question regarding liens and how that works. The uncollected funds are turned over to fiscal who then submits it to central collections. If the bill is not paid within 5 years, the property owner runs the risk of foreclosure. The property owner can work with central collections to have the lien applied to the tax bill. If the lien is not collected then, it will be collected when the property sells. My understanding is that it will continue to accrue interest.
- Dan Is there a tracking mechanism?
- Inta Not sure, it's a different agency, but will look into it.
- Dan Will our ordinance still follow that same process for unpaid fines?

- Inta We send a copy of the letter with the fine and ask the property owner to include the letter with the check when they send it back so that they can track it. When it's paid, I write in my spreadsheet that it's paid. Not sure about larger fines that are collected, but it may go directly through fiscal.
- Lupe We need to double check with Central Collections and Tona Henninger regarding enforcements and procedure for collecting the fines.
- Inta In our last meeting there was a question regarding a permit fee increase. According to the ordinance, Chapter 12.08.190, the Director has the discretion to raise the fees, as he deems necessary. I wouldn't recommend it yet since the program is so new.
- Dan How much is the application fee? How much is the appeal fee?
- Inta \$35 app fee, \$25 appeal fee (to the Director/TAB)
- \$50 appeal fee to the BOS

## VI. Other

- Inta Steve asked Jim Tarantino and myself to look into several locations where we might be interested in using rubber sidewalks. Several in Castro Valley along Grove Way, Tanglewood, Watson, and Fairmont Terrace. Fairmont Hospital may be used because it's already County owned. The company who produces these has contractors who will maintain these sidewalks so we're trying to get a bid on installation and maintenance.
- Kathie There should definitely be some put in San Lorenzo
- Inta This is strictly based on species of tree, amount of damage and if there are any other options available.
- Inta Property owner would have to approve and pay the extra cost. The county can't pay for it because it would be considered a gift of funds.
- Inta At least 2 of the 140 Pistache trees on Castro Valley Blvd have Verticillium Wilt, which is a soil borne fungus. You can't plant the same tree back in that spot.
   We met with the state agricultural plant pathologist who verified the infection. We're working on a maintenance schedule and guidelines for these trees. I'm also putting together a letter to send out to adjacent property owner regarding this. These are trees that can live on with the proper maintenance.
