### **IV. Violation Hearings**

### 57 Via Hermosa, San Lorenzo

Inta- Tree at this address had been topped and appeared to be trimmed on more than one occasion. A violation letter was sent to the owner. The owner called in response to the letter stating he trimmed the tree to slow the root growth. He stated the roots were damaging his driveway, sidewalk, and waterline. He then requested to remove and replace the tree. Motioned and carried that resident will replace tree with a 24" box tree and be fined \$250. Inta will work with him on what type of tree to plant.

Tom Guarino sent letters to the San Lorenzo Homes Assoc. informing them they've changed their contractor back to Davey Tree. He's also been working with the Homes Assoc. on a grant program.

Audrey recommends having the homeowner supply info that they're using a County permitted contractor. There is no fee if they use a contractor with a permit on file.
