# **MINUTES**

## IV. Hearings: 17060 Via Toledo, San Lorenzo, CA. 94580

Staff responded to a complaint from SLVHA regarding a Sycamore that was severely cut. Staff inspected and found the tree was most likely topped some years ago and had been improperly pruned. The entire canopy had been removed.

The owner stated that he had the tree cut because he has several grandkids and was concerned with the bird feces being tracked into the house. He had a friend that was a former Davy's tree climber, trim the tree.

Motion by Kathie Ready for Mr. Baker be fined \$750.00 (1/3 loss of value) plus \$100.00 (fine for work without permit)

Dee McDonough amended the motion to reduce fine to \$500.00 (loss of value) plus \$100.00 (fine for work without permit) and include restorative pruning.

Motion approved 3-1 Don Nelson opposed.

## **Recommendation:**

It was recommended that Mr. Baker be fined \$500.00 (loss of value) plus \$100.00 (fine for work without permit) plus restorative pruning.

## 17345 Via Julia, San Lorenzo, CA. 94580

Staff responded to a complaint regarding a tree being removed. Staff mailed notice of violation. The property owner called and stated she pruned the female Ginkgo tree because it was smelly and messy and interfering with the wires. She reported fruit and leaf droppings were a hazard to the kids walking to school. She said it made the road and sidewalk slippery.

Property owners stated they did not know that pruning of a tree required a permit. They trimmed the tree as a temporary fix to eliminate the bad smell and pedestrian hazard.

Motion by Don Sheppard to remove the tree and replace with 24" boxed Sycamore plus \$100.00 (fine for work without permit)

Motion seconded by Donald Nelson

Motion approved 3-1 Kathy Ready opposed.

# **Recommendation:**

Remove the tree and replace with 24" boxed Sycamore plus \$100.00 (fine for work without permit)

# 1086 Via Corolla, San Lorenzo, CA. 94580

Staff was notified that a tree was being removed. Staff inspected and the tree was improperly pruned and was possibly being removed. Letter of violation was mailed. Lupe Serrano called the property owner to explain the ordinance and violation process.

Mr. Chavez stated he was not aware of the permit requirements. He had pruned the tree in past years and this year pruned it more because of the damage to his sewer.

Motion by Donald Nelson to remove the tree and replace with a 24"boxed tree, plus \$100.00 (fine for work without permit)

Motion seconded by Dee McDonough

Motion approved 3-1 Kathy Ready opposed.

Remove the tree and replace with a 24"boxed tree, plus \$100.00 (fine for work without permit)
