# **Mandatory Pre-Proposal Meeting Questions**

- 1. Is increasing/promoting walking and biking to school a project goal? Yes, but not the primary goal. (Page 5) it is In addition to reducing biking and walking and biking accidents.
- 2. If the project schedule is extension is approved by the CTC, what is the likely change to the deadline one or two weeks?

If approved the County is considering a minimum of two weeks extension. The County will notify perspective bidders by Monday, October 24<sup>th</sup>. Therefore, the consultants should proceed under the current schedule until further notified.

- **3.** Who is the audience for the presentation listed in the task deliverable? The County staff, Technical Advisory Committee, and the schools.
- Does a Powerpoint need to be developed for each of the schools?
  No. A Powerpoint with each school critical information listed on one page should be sufficient.
- 5. Where does the scope of work get insert the proposal? Originally, it was intended to go into the Experience section. However, it was agreed to add a Scope of Work section after the Experience section. The section should be limited to 10 pages.
- 6. Who should you contact for additional questions? Anita Franklin. Her contact information can be found in the Request for Proposal.
- 7. When is the deadline for submitting questions? Wednesday, October 19, 2016, by 2 p.m.
- 8. When will the final RFP Addendum be available? Monday, October 24, 2016 by 5 p.m.

## 9. What is the funding source?

The funding source comes from the Active Transportation Program Cycle 1 grant award in the amount of \$668,000. Please note that some of the funds have been set aside for the County project administration.

# 10. What is the project implementation timeline?

Tasks 1 through 6 should be completed by June 30<sup>th</sup>, so that the County can begin to implement recommendations before the school year begins in August. Projects will be reevaluated at the end of the first school year and program modifications are expected to be made to enhance the program.

# 11. Is County trying to identify roadway capital projects?

Yes. The County is open to all types of engineering countermeasures; however, the recommendations must be supported by the analysis. The projects can minor and major and short-term and long-term.

# 12. Do you have background data for the schools?

Yes. For some schools, but most data is outdated or incomplete.
