Attached is an updated progress report on County Procurement. The information presented in this report is based on payments made to contractors. The summary chart of all payments up to \$500,000 for the period July 1, 2009 through September 30, 2022 is shown on Page A1 and includes:

- Total payments up to \$500,000 were \$1.8B
- \$1.1B was paid to local contractors which equals 60.58% of total dollars up to \$500,000
- \$884.6M was paid to MWBE/SLEB contractors which equals 49.20% of total dollars up to \$500,000
- Payments to MWBE/SLEB contractors by category were:

Construction: \$86.4M which equals 38.03% of Construction dollars

Architecture & Engineering: \$24.4M which equals 50.78% of Architecture & Engineering dollars Professional Services: \$342.2M which equals 60.34% of Professional Services dollars \$431.6M which equals 45.16% of Goods & Services dollars

Also included in this report are all payments to contractors including amounts over \$500,000. This data is presented in the summary on Page A2 for the period July 1, 2009 through September 30, 2022 and includes:

- Total payments were \$4.0B
- \$2.2B was paid to local contractors which equals 54.49% of total dollars
- \$1.4B was paid to MWBE/SLEB contractors which equals 35.68% of total dollars
- Payments to MWBE/SLEB contractors by category were:

Construction: \$233.5M which is 30.04% of Construction dollars

Architecture & Engineering: \$29.3M which is 35.70% of Architecture & Engineering dollars Professional Services: \$462.0M which is 30.40% of Professional Services dollars \$713.1M which is 43.18% of Goods & Services dollars










Local Utilization - All Construction Payments




















Local Utilization - All Professional Services Payments





















F2 - 7/1/09 - 9/30/22 - Overall Local Utilization by Dollars





F3 - 7/1/09 - 9/30/22 - Overall Local Utilization - Goods and Services by Dollars
