Attached is an updated progress report on County Procurement. The information presented in this report is based on payments made to contractors. The summary chart of all payments up to \$500,000 for the period July 1, 2009 through December 31, 2022 is shown on Page A1 and includes:

- Total payments up to \$500,000 were \$1.8B
- \$1.1B was paid to local contractors which equals 60.40% of total dollars up to \$500,000
- \$905.8M was paid to MWBE/SLEB contractors which equals 49.12% of total dollars up to \$500,000
- Payments to MWBE/SLEB contractors by category were:

Construction: \$89.0M which equals 38.13% of Construction dollars

Architecture & Engineering: \$25.1M which equals 51.02% of Architecture & Engineering dollars Professional Services: \$351.6M which equals 60.16% of Professional Services dollars \$440.1M which equals 45.05% of Goods & Services dollars

Also included in this report are all payments to contractors including amounts over \$500,000. This data is presented in the summary on Page A2 for the period July 1, 2009 through December 31, 2022 and includes:

- Total payments were \$4.1B
- \$2.2B was paid to local contractors which equals 54.23% of total dollars
- \$1.5B was paid to MWBE/SLEB contractors which equals 35.72% of total dollars
- Payments to MWBE/SLEB contractors by category were:

Construction: \$239.7M which is 30.01% of Construction dollars

Architecture & Engineering: \$30.0M which is 36.07% of Architecture & Engineering dollars Professional Services: \$476.1M which is 30.53% of Professional Services dollars \$729.2M which is 43.20% of Goods & Services dollars















F2 - 7/1/09 - 12/31/22 - Overall Local Utilization by Dollars





