Attached is an updated progress report on County Procurement. The information presented in this report is based on payments made to contractors. The summary chart of all payments up to \$500,000 for the period July 1, 2009 through June 30, 2021 is shown on Page A1 and includes:

- Total payments up to \$500,000 were \$1.56B
- \$963.6M was paid to local contractors which equals 61.86% of total dollars up to \$500,000
- \$773.1M was paid to MWBE/SLEB contractors which equals 49.64% of total dollars up to \$500,000
- Payments to MWBE/SLEB contractors by category were:

Construction:	\$79.3M which equals 39.24% of Construction dollars
Architecture & Engineering:	\$20.4M which equals 53.77% of Architecture & Engineering dollars
Professional Services:	\$293.5M which equals 61.04% of Professional Services dollars
Goods & Services:	\$379.9M which equals 45.41% of Goods & Services dollars

Also included in this report are all payments to contractors including amounts over \$500,000. This data is presented in the summary on Page A2 for the period July 1, 2009 through June 30, 2021 and includes:

- Total payments were \$3.44B
- \$1.94B was paid to local contractors which equals 56.37% of total dollars
- \$1.23B was paid to MWBE/SLEB contractors which equals 35.82% of total dollars
- Payments to MWBE/SLEB contractors by category were:

Construction:	\$206.0M which is 30.55% of Construction dollars
Architecture & Engineering:	\$24.5M which is 34.76% of Architecture & Engineering dollars
Professional Services:	\$392.4M which is 30.93% of Professional Services dollars
Goods & Services:	\$610.3M which is 42.69% of Goods & Services dollars
